  - BE IT RESOLVED that the Board approve and adopt a final 2015-16 School Budget in the amount of \$11,130,354.00 for the General Fund (Current Operating Expense), \$145,000.00 for the Special Revenue Fund (Federal & State Grants), and \$147,447.00 for the Debt Service Fund, and
  - BE IT FURTHER RESOLVED that there should be raised for the General Fund \$10,487,978.00 (+2.25%) through local taxation to support the Current Operating Expense Budget and \$147,447.00 through local taxation to support the Debt Service Fund for the 2015-16 School Year, and

### A. GOOD NEWS

Churchill School

#### School-Wide

- Students at Churchill participated in the Reading Challenge "Hit the Books", producing close to 100,000 minutes of reading on their own, at home.
- Students at Churchill were visited, on April 22, by about two dozen "professionals" for "Career Day" working in thirty minute sessions, and learning about careers from public relations to engineering to journalism and dozens more.
- Students at Churchill are reading poetry, in honor of POETRY MONTH and Ms. Goodman highlighted two favorites "Joyful Noise: Poems for Two Voices" by Paul Fleischman and "Gone Fishing, A Novel in Verse" by Tamera Wissinger. Also, there has been a short, weekly poem read on the morning announcements.

### • Grade 6 & Grade 5

Students in Grade 6 and Grade 5, from the Theater Club performed "Peter Pan" for the school assembly, on Thursday afternoon – and the final performance on Thursday evening.

#### • Grade 4.

The fourth grade students had a great time on their field trip to Sandy Hook. Students were able to participate in seining at the salt marsh while wearing waders and using a net. They also had a chance to explore the beach where they collected and identified different seashells and other shoreline finds.

### Stevenson School

Students in kindergarten through Grade 3 participated in the 5<sup>th</sup> annual Science and Technology Fair and Art Expo on April 16<sup>th</sup>. Projects encompassed many disciplines including, Chemistry, Physics, Biology, Earth, Life, and Physical Science. This year we incorporated technology into the Art Expo by using the Aurasma App. Student video presentations on various artists were activated by holding an IPad (camera) over a picture of a student artist. Special thanks to Miss Cecere for the Art Expo, Ms. Mulvaney for the tech support and introducing the app to our students and all of the students who participated and teachers who attended.

I am pleased to announce that Stevenson was selected to receive a 2015-2016 NJEA Frederick L. Hipp Foundation for Excellence in Education grant. The project, Grow, Eat, Learn: A School Garden Project will be funded in the amount of \$1,453.00. Congratulations Ms. Chavkin for successfully securing funds for this program!

To celebrate Earth Day on April 22, the Third Grade participated in the annual Third Grade Tree Team Project through the NJ Forest Service, giving every third grader a free tree seedling when requested by the local school. It acquaints young students with the value and importance of trees, increasing environmental awareness, and teaches students about the benefits of trees. Thanks to Mrs. Pechko, each Third Grade class received a bundle of 20 Nordic Spruce seedlings. Each student was able to select a seedling, wrap the roots in moist newspaper, and pack the seedling into a small bag to transport home. Six of the seedlings were proudly planted on the front property at Stevenson School. We look forward to watching our new trees blossom and grow into majestic adult Nordic Spruce Trees in the years to come.
