B. Good News

Stevenson School

- Kindergarten has started their new Social Studies program. They have been busy learning about being a good citizen. The young citizens learned about getting along with others, feelings, school rules, laws and confronting problems with solutions. The students are enjoying the magazine readers that go along with each one of THE Social Studies themes.
- The first graders learned how to make applesauce after learning about Johnny Appleseed. Each class made and tasted the applesauce. The students discussed and wrote their opinions about the process of making the applesauce and how it tasted. The classrooms and hallways smelled delicious!
- Second graders have been getting ready for Autumn! They created pumpkin math projects using dice for addition and making fact families. They finished their first writing unit in Empowering Writers. They have been practicing identifying narrative and expository/informative pieces of writing. Second graders have been analyzing and annotating each writing piece and predicting genre. They also have been learning how to work together to solve problems and practice math facts and skills through Math Games!
- Students in third grade have just finished their first novel, <u>The Miraculous Journey of Edward Tulane</u>. Students are working together to complete the culminating project. They will be completing their fall writing and will create narrative stories using a variety of different figurative language skills. Aligning with the new Science standards, the Science curriculum has been engaging students; and they are so excited to learn more!
- Student council had their first meeting. Thirty third graders have joined the student council this year. The first activity will be a collection for "The Blessing Bag Brigade." This organization collects every day toiletries for the homeless. Once items are collected, the organization has individuals with special needs work on their life skills by packing bags. Stevenson students will collect the following items from October 10 through 19: travel size lotion, toothpaste, shampoo, body wash, socks, and breakfast bars. They are hoping to fill many blessing bags through their collection.

- HEP: Third grade students are beginning to construct their greenhouse pods for the garden out of water bottles, dowels, rubber bands, tape and other items. They have planned out their "greenhouse pod" using a diagram already! SO EXCITING!!!
- Stevenson students have been busy in the art studio. They have been working with a variety of art mediums to create autumn themed pictures to adorn the yellow hallway just in time for Halloween. Kindergartners and first graders have been learning about warm and cool colors, while second and third graders have been exploring the art element of line. Our artists are excited for their school community to enjoy their work in the near future!

Churchill School

- The fourth grade is diving into the world of addition and subtraction strategies in mathematics. The students effectively estimate sums and differences before solving word problems using three different estimation strategies. The students have been learning about energy explorations which have allowed them to experiment and learn. They have learned about different types of energy through different experiments such as using ping pong balls and marbles to learn about how energy is transferred and converted. Finally, the students are enjoying the adventures in their current novel, "The Cricket in Times Square." They are making inferences about character traits through specific actions and dialogue within the story.
- Fifth grade students are making amazing connections between studying area and volume in mathematics and matter's density (its mass compared to its volume) in science.
- As part of the Sixth grade Social Studies unit on Origins of Civilization, students had to bring in an artifact from home to present to their class. An object had to be at least twenty years old to be considered an artifact. Some of the most interesting ones were a 45 vinyl record for a turntable, a handmade wooden train set, a potato masher, a newspaper clipping about the end of World War II, a pocket watch, and a ticket to a World Series in which the Yankees won!

• Churchill students have been busy at work in the art studio. They are in the process of creating some fall themed pieces. The fourth graders are studying Pablo Picasso and the art movement of cubism, while fifth graders are experimenting with the medium of paint. Sixth graders are creating realistic drawings using chalk pastels that are sure to amaze. These student artists are excited for their school community to enjoy their work in the near future!
