**BE IT RESOLVED** that the Board approve and adopt a Tentative 2018-2019 School Budget in the amount of \$11,950,652 for the General Fund (Current Operating Expenses), \$214,581 for the Special Revenue Fund (Federal & State), and \$93,220 for the Debt Service Fund; and

**BE IT FURTHER RESOLVED** that there should be raised for the General Fund \$11,378,705 through local taxation to support the Current Operating Expense Budget and \$93,220 through local taxation to support the Debt Service Fund for the 2018-2019 School Year, and, to authorize the administration to submit same to the Essex County Executive Superintendent of Schools for review and approval; and

**BE IT FURTHER RESOLVED** that the Fairfield Board of Education include in the tentative budget the adjustment for enrollment in the amount of \$53,037. The District intends to utilize this adjustment for supplies and materials for the additional students; and

**BE IT FURTHER RESOLVED** that the Current Expense Operating Budget includes \$11,560 for maximum travel expenditures in accordance with N.J.S.A. 6A:23A-7.1.
