C. The Good News

Stevenson

- February was a very interesting month for kindergarten students. In Social Studies, time was spent learning all about the presidents, especially Abe Lincoln and George Washington. Math was incorporated into lessons by focusing on coins. Students practiced counting by ones with pennies and by tens with dimes. For Black History Month, students learned about famous African American inventions. Did you know that the traffic light, ice cream scooper, pencil sharpener, peanut butter, and mailbox were all invented by African American Inventors? The kindergarten students do!
- First grade students enjoyed Read Across America and celebrated Dr. Seuss's birthday by reading multiple Dr. Seuss books. The Cat in the Hat was read and various story elements were discussed. The first grade classes combined and read Horton Hatches the Egg. Students then partnered with a classmate to create their own animals through writing and drawing. "Green Eggs and Ham" (actually powdered donuts with green cool whip) were enjoyed by all!
- During the month of February, second grade students wrote opinion pieces about the African American that made the greatest influence on America. They studied Martin Luther King Jr., George Washington Carver, and Ruby Bridges. Second graders also were busy utilizing the computers in the classroom and are now using Google Classroom at home as well!
- This month, the third grade students have been working hard on finishing the second science unit. Students have used what they know about adaptations and ecosystems and created their own ecosystem. They have also been working hard outside of school to work on their biography Pop Bottle figures.
- Third grade HEP students continue refining their Challenge 24 skills by leveling up to double digits. Students use order of operations to add, subtract, multiply, and divide to get to the number of make 24 by using double digits.

- First grade HEP students continue to code by looping, to repeat their Blockly commands over again. Students also had the opportunity to learn Java Script when learning Blockly Based Coding.

Churchill

- Mrs. Colon's sixth grade DI class and Ms. Sarna's fourth grade DI class have been working on projects researching Winston Churchill. Mrs. Colon's class worked in groups to create slideshow presentations about his early life, political career, his impact during WWII, and his legacy. Then students worked individually to research Churchill's famous quotes by choosing a quote, defining the quote and relating it to their own life. Mrs. Sarna's group worked to create posters or slideshows about Churchill's life. Students sought to learn more about the individual whom our school was named after. They were required to include their thoughts on why the school was named after this influential individual. Both groups presented their work to each other and will use this information as background knowledge in their Holocaust studies.
- Churchill School's Student Council, along with the support of Fairfield Unico and Fairfield Knights of Columbus, celebrated "Mardi Gras for Lauren" on March 5. Lauren, Fairfield Public School's alumnae, was recently diagnosed with Aplastic Anemia and recently had a bone marrow transplant. The students dressed up in Mardi Gras gear, had their faces painted, took a chance at guessing jars, and enjoyed King Crown cupcakes and Moon Pies. It was a spirited day for everyone! The generosity of the Churchill School community helped students to donate \$2,146.00 to help offset the medical costs of Lauren's treatment. The Student Council sincerely thanks all those who helped to make this day a success and all those who contributed to help Lauren in her fight against Aplastic Anemia.
- Students in grade four are currently working through the steps of the writing process to complete an opinion writing assignment. The assignment has them making persuasive arguments supported with evidence from reputable sources. In science, students are studying animal and plant structures. They will have the opportunity to take part in some unique experiments such as: growing radish plants, dissecting squids, and investigating the internal organs of the squid. Students are currently learning about how market economy works. By taking part in some interesting economic lessons, the fourth graders are learning about how goods and services, as well as producers and consumers, work together to form the country's economy.

- Fifth graders hosted and ran their "Carnival of Escape Rooms". Students set-up their escape rooms in the gym and fifth grade classrooms. All grades had the opportunity to test out each escape. They were thrilled to hear that News 12, Tap into West Essex, and The Progress were there to capture the excitement! The fifth graders are now diving into their colony project and are looking forward to presenting at the Board of Education meeting on March 19.
- Sixth-grade students donated roughly 230 books to the Fairfield Public Library. Nearly 67 students participated in this generous act. These books will be used for the library's summer reading program!
